Elevada a Consejo de Gobierno, por parte de la Vicerrectora de Compromiso Social y Sostenibilidad, propuesta de Acuerdo de aprobación del documento de compromiso de la Universidad Autónoma de Madrid con la política de protección y salvaguarda de la Infancia (Child Protection Policy / Política de Salvaguarda. Universidad Autónoma de Madrid), previo acuerdo de la Comisión de Compromiso Social y Sostenibilidad, de fecha 3 de abril de 2024, al amparo del artículo 46.2 l) de la Ley Orgánica 2/2023, de 22 de marzo, del Sistema Universitario, este Consejo de Gobierno APRUEBA el documento de compromiso de la Universidad Autónoma de Madrid con la política de protección y salvaguarda de la Infancia (Child Protection Policy / Política de Salvaguarda. Universidad Autónoma de Madrid), conforme texto literal que a continuación se inserta.

### **CHILD PROTECTION POLICY / POLÍTICA DE SALVAGUARDA UNIVERSIDAD AUTÓNOMA DE MADRID**

Universidad Autónoma de Madrid (UAM) is fully committed to safeguarding the welfare of all children in its care. It recognises the responsibility to promote safe practice and to protect children from harm, abuse and exploitation.

For the purposes of this policy and associated procedures a child is recognised as someone under the age of 18 years.

UAM's staff will work together to embrace difference and diversity and respect the rights of children and young people.

This document outlines UAM commitment to protecting children. These guidelines are based on the following principles:

- The welfare of children is the primary concern.
- All children, whatever their age, culture, disability, gender, language, racial origin, socio-economic status, religious belief and/or sexual identity have the right to protection from all forms of harm and abuse.
- Child protection is everyone's responsibility.

- Children have the right to express views on all matters which affect them, should they wish to do so.
- Organisations shall work in partnership together with children and parents/carers to promote the welfare, health and development of children.

Universidad Autónoma de Madrid will:

- Promote the health and welfare of children by providing opportunities for them to take part in our focus groups, activities or interactive environments safely.
- Respect and promote the rights, wishes and feelings of children.
- Promote and implement appropriate procedures to safeguard the well-being of children and protect them from abuse.
- Recruit, train, support and supervise its staff, members and volunteers to adopt best practice to safeguard and protect children from abuse and to reduce risk to themselves.
- Require staff, members and volunteers to adopt and abide by this Child Protection Policy and these procedures.
- Respond to any allegations of misconduct or abuse of children in line with this Policy and these procedures as well as implementing, where appropriate, the relevant disciplinary and appeals procedures.
- Observe guidelines issued by local Child Protection Committees for the protection of children.
- Regularly monitor and evaluate the implementation of this Policy and these procedures.

Review :

- This Policy and these Procedures regularly reviewed:
  - In accordance with changes in legislation and guidance on the protection of children or following any changes within Universidad Autónoma de Madrid.
  - Following any issues or concerns raised about the protection of children within Universidad Autónoma de Madrid
  - In all other circumstances, at least every three years.
